



ECCF COMPETITIVE GRANT ACCEPTANCE AGREEMENT

I. Conditions of Grant

This Form refers to and incorporates the grant to {{check.profile_name}} from the Eau Claire Community Foundation (ECCF). The undersigned agrees to the following conditions:

II. Grant Restrictions

- You may not use any portion of the grant funds to undertake any activity for any purpose other than one specified in the award letter without ECCF's prior written authorization. Expenditures must be in accordance with section 170(c)(2)(B) of the Internal Revenue Code.
- This grant cannot be used to satisfy the payment of any pledge or other personal financial obligation on behalf of the donors.
- Your signed acceptance of this grant letter certifies to ECCF that no tangible benefit, goods
 or services (such as memberships, dinner, or tickets), are received by any individuals
 and/or entities connected with the donors.
- Funds must be used in compliance with all applicable anti-terrorist financing and asset control laws, statutes and executive orders.
- The grant awarded may not be used to influence the outcome of any specific public election or to carry on, directly or indirectly, any voter registration drives within the meaning of Internal Revenue Service Code Section 4945(d)(2).
- You must return any funds not expended for the purpose of the grant within the grant period.
- Follow-up site visits may be requested.

III. Tax Exempt Status

As a condition to the receipt of the grant funds announced in the Award Letter, the undersigned agency certifies that it is exempt from federal taxation under section 501(c)(3), 170(b), 509(a)(1) or (2) of the IRS code, and that it isn't a private foundation as defined by Internal Revenue Code Section 509. The receiving organization will advise ECCF immediately if the federal government gives notification that the organization's tax status is changed or is being reviewed, if there's a change in the grantee staff responsible for administering the grant, or if the grantee is no longer able to expend the grant for its intended purpose.

IV. Records Retention

In accordance with IRS regulations, records of receipts and expenditures under this grant, as well as copies of reports submitted to ECCF, should be kept for at least seven years following completion of such receipts and expenditures.
